Products of Foche are for laboratory research purposes only, and are not to be used for any other purposes, including but not limited to, in vitro diagnostic purposes, in foods, drugs, medicinal devices or cosmetics for humans or animals, for any commercial purposes or the production of illicit drugs. Also all products are not intended by their manufacturer for human use or consumption. The chemical, physical, and toxicological properties of these chemicals have not been fully investigated and are not guaranteed. Buyer acknowledges that the products have not been tested by Foche for safety and efficacy in food, drug, medical device, cosmetic, commercial or any other use. Buyer expressly represents and warrants to Foche that Buyer will properly test, use, manufacture and market any products purchased from Foche and/or materials produced with products purchased from Foche in accordance with the practices of a reasonable person who is an expert in the field and in strict compliance with all applicable laws and regulations, now and hereinafter enacted. Buyer further warrants to Foche that any material produced with products from Foche shall not be adulterated or misbranded and shall not be materials which may not be introduced into commerce.

Buyer realizes that, since Foche products are for research purposes, they may not be on the Toxic Substances Control Act (TSCA) inventory. Buyer assumes responsibility to assure that the products purchased from Foche are approved for use under TSCA, if applicable.

Our products are not applicable for the acquisition, possession or use of persons under 21 years. They should also not be ordered for other people to avoid that age limit.

Buyer has the responsibility to verify the hazards and to conduct any further research necessary to learn the hazards involved in using products purchased from Foche. Buyer also has the duty to warn Buyer's customers and any auxiliary personnel (such as freight handlers, etc.) of any risks involved in using or handling the products.
